

Cathy, together with Jim Thompson and with the pandemic as a catalyst, has led the move towards a new way of engaging with the congregation, and indeed with the entire global community through "live streaming" of the weekly Sunday services. After some time spent recording and posting services online, the church has elevated these capabilities through a modest investment in equipment combined with Jim's stellar technical prowess, to facilitate watching of our services on "live TV"!! So anyone in the world can now tune in on Facebook. If you're really tech savvy at home you can "cast" the livestream from your phone onto a TV so it really is just like watching "Hockey Night in Canada", sort of...

After two years of council meetings being conducted virtually over "Zoom" I can say this technology really has helped keep the ball rolling in terms of seamless conducting of the affairs of the church. Really it's been rather painless and I even wonder at this point if there will be an appetite amongst some council members to returning to get in the car to drive through the winter nights to the meetings. Naturally, to suggest the pandemic has altered activities of BUC would be a profound understatement. More than anything the glue that has proven to bind us together during these times consists of the pre-recorded/live Sunday services produced by Jim Thompson, and featuring Reverend Cathy, Wendy Dunits, Sue Liczkowski, Ian Deslauriers, and others. Finally a big THANK YOU as well to all our other council and committee members that help keep our building and church family running smoothly all through the year in spite of it all. Reopening of Bridgenorth United Church

As we are all well aware of, Covid-19 is still affecting our daily lives, and it looks like it will continue to do so, for a while.

After about a year and a half of online services, we were able to open our doors again, on Sept. 12 for in person worship. We follow, <u>very closely</u>, the <u>Public Health Covid 19 protocols</u>, and our main objective, is to keep everyone safe and enjoy our "in Sanctuary" worship services. With proof of a double Covid Vaccine and being screened at the door for Covid symptoms and Contact tracing, we were successful in keeping everyone safe!

Unfortunately our "in Sanctuary" services were short lived, and we were needing to close for in person worship, again after the Services on Sunday Dec. 19, due to increased Covid numbers in our area.

On Sunday Feb. 8th we reopened, yet again, for in person Worship, with the same protocols in place. We were all relieved to be back, and hoping that we will continue to stay open, as Covid numbers are hopefully starting to decline.

As certain mandates are starting to open up such as public places starting to drop the proof of vaccinations, increasing numbers allowed in side, etc., the Reopening Committee met, by Zoom on Tuesday March 1st, to decide if we should be changing our Protocols for Sunday services. It was decided (6 voting in agreement and 2 abstaining), that we keep our current Protocols in place, until we can discuss it further with the Congregation at our Annual Meeting on Sunday April 3rd. At that point, we will be looking for feedback from the Congregation, on whether we are willing to open things up again, with no restrictions.

A huge thank you to our reopening committee volunteers who helped every Sunday to keep our congregation safe! Without these dedicated members, we would not have been able to meet in person on Sunday Mornings.

** Please remember, as well, that the protocols that we have put in place, follow the Public Health and Government Rules. These protocols are to keep everyone safe. Please be patient and hopefully we can get back to a more normal way of worship soon.

Outreach & Justice Committee and Food Bank

In 2021 the 6 members of the Outreach & Justice Committee were Patty Latour and Anna Thompson (co-chairs), Linda Guppy, Sandra Forsey, Donna Mackey and Deb McCutcheon.

Our BUC Food Bank has 20 amazing volunteers, a combination of members of our congregation and members of our community – truly a community endeavor. We are known for our friendly, personalized and non-judgmental service. Thank you to everyone for your dedication and compassion.

In 2021, BUC started including the **Curve Lake First Nation Land** Acknowledgement at the beginning of services and council meetings.

Our committee donated \$215 to the United Church of Canada Indigenous Truth and Reconciliation Fund.

Food Bank - During the Covid pandemic, the BUC Food Bank has remained open every Tuesday. We have seen a 30% increase in the number of households needing to visit our food bank in the last year. Two years ago, before the pandemic, we were averaging 30 to 32 households per month and now we are averaging 50 to 52 households per month. The good news is that the congregation and the community have responded with overwhelming support. We are blessed with generous donations including groceries, money and gift cards.

Winter Food Drive – MPP Dave Smith's Winter Food Drive was on November 27, 2021 at John's Independent Grocer in Bridgenorth. It was the most successful food drive in Peterborough County. Thank everyone!

Provincial Funding – The food bank received a Provincial grant to assist with the costs of increased demand and operational adjustments required due to Covid impacts. The funds were used to construct additional, more sturdy shelving in our food storage area (labour donated by Gil Sperry and Larry Ross). We also used the grant to have 4 large mobile shelving carts custom made for the food hampers. We heed 20 hampers totally 80 bags of groceries available each week.

The end of December, we were grateful to receive another Provincial Grant to be utilized in 2022.

The BUC Food Bank is not financially dependent on the Church Operating Account for funding. About 70% - 75% of our inventory comes from Kawartha Food Share, so to provide a good variety of healthy foods and toiletry items we continue to need donations of money and groceries. The congregation and community have been wonderful in their support of the BUC Food Bank ministry.

Property Committee

While the Church Council has been able to meet virtually, most of the Property Committee members do not have computers or internet access, so the Property Committee has not held meetings since the pandemic lockdown. However, we are in regular contact by phone the property maintenance has continued. Some of the issues dealt with are:

- The "Be An Angel" stable display was installed again by Gil Sperry, Larry Ross and Jim Thompson. The stable will be taken down when the snow and ice melts.
- The Nexicom internet and phone connection was upgraded to a Fibre optic connection, providing significantly faster upload and download speeds. The timing of this upgrade matched the installation of the Live Streaming video system.
- Jim Thompson installed equipment at the sound board to provide service video recordings and live streaming to Facebook. Jim Thompson has been training Steve Kirton and Jeff Julian to operate the video and Live Streaming system.
- Jim Thompson has also been busy with service recordings, editing and posting to Facebook and website.
- The shingles on the Manse and Manse Garage were replaced by Feeney roofing in December.
- The 2nd floor toilet in the Manse was replaced by Jim Thompson.

- The church office computer was replaced with an updated computer donated to BUC by Tanna Edwards.
- WIFI use by Trent Childcare for virtual learning identified issues with the network switch and ethernet cables. Jim Thompson replaced the switch and printer ethernet cables reconfigured the router to eliminate IP conflicts.

Budget Introduction

The attached budget displays the three primary funds for BUC on one worksheet. This format is used in monthly reports to the Church Council on the financial status of the church and its various programs.

Budget Approach to Offerings

This budget reflects General Offerings for the Local and Building fund that were achieved in 2021 and adjusted for excess Food Bank donations. These actuals were then increased by a 10% target. To meet the givings targets we will require increased Local Offerings from the congregation and continued support from the Bridgenorth community.

Budget Approach to Operations and Fundraising

The budget assumes a full resumption of services for approximately 80% of the year and and the return of fundraising events throughout the year. Event convenors and support are required - so please reach out to the Membership Committee for a role in these events.

Budget Expenses

The operating expenses of the church are quite consistent and include projected expenses based on good historical data and known changes.

Best estimates have been used, fully understanding that we are emerging from the COVID19 pandemic and finding our way under new operating conditions.

In the Building Fund, an estimate has been included for some HVAC repairs/replacements. Roof repairs may be required as well and will be investigated later in 2022.
